



Fool Me Once... Fool Me Twice... A Fresh Perspective on Fool's Gold By M. O'Brien

Due to its pale yellow color, metallic luster, and shape, the substance pyrite has the well-earned moniker of "Fool's Gold." Found all over the world, this substance is an ironsulfide mineral that easily oxidizes. Modern industries rely on pyrite for an easy source of sulfuric acid and it is used in the making of paper as a source of sulfur dioxide. The name pyrite is sourced from the Latin term for fire due to it's ability to create a spark when struck. Despite all these uses, few would consider pyrite as precious as gold.

Researchers looking at pyrite on a macro scale found both nano particles of gold and an accumulation of gold particles between the crystalline structures hidden in

deformation pockets, also called dislocations. Using a process of selective leeching, the team was able to extract all the gold without destroying the fundamental mineral structure of the pyrite.

Dr. Denis Fougerouse stated that a fluid was used to dissolve the gold in a way that allowed dislocations act as fluid highways for the gold to exit. This leaves the potential for the pyrite to remain usable for other applications. The amount of gold retrieved is potentially feasible to justify extraction when the wide availability of the mineral is considered. In the end proving that Fool's Gold is worth a second look.

### **BEWARE WHAT YOU CLICK!!**

Please be reminded that those emails you get from time to time that appear to come from your club president or other club official may not be legitimate. They typically begin with phrases like "do you have a moment", a payment of some amount is urgently needed, etc., etc. Unfortunately, it is easy to fall into the trap and end up responding to one of these emails or worse yet, actually sending money. It was brought to my attention that some of these "phishing" emails reference the upcoming Convention and Show. As the AFMS Treasurer as well as the CFMS Executive Treasurer, I generally get anywhere from 2 to 6 of these a week. Usually they appear to come from the organization's president. If in doubt about who sent the email, send an email to the real person and ask if they sent you a message requesting a particular action. If you click on the name of the sender, the email address of the real sender will be revealed. Most of the ones I've received are gmail addresses; others actually originated in other countries. Never once has the email address actually been one used by the person being impersonated. If a link or attachment accompanies the email, do NOT click on it. Doing so could introduce a harmful virus to your device that could disable your computer or even worse, steal personal information. What is the best way to avoid falling victim to these cyber=criminals? Learn what to look for and when a suspicious email comes your way, DELETE, DELETE, DELETE!!

### **Unusual Legacies of the Californian Gold Rush**

Gold nuggets shining from under the river's currents form much of our image of the Gold Rush era along with mobs of prospectors with gold fever shining in their eyes swarming the untouched

Californian landscape. This watershed moment surprisingly led to several more unusual legacies of cities built on ghost ships, financial calamities, and future global fashion icons.

Many prospectors ventured to California by boat through the San Francisco Bay harbor. Without any cargo, passengers, and in some cases, crew, for a return journey many vessels sat abandoned all over the harbor area. Entrepreneurial locals began to sell the timber or repurpose the structures into saloons, brothels, hotels, and warehouses. Derelicts were used as landfill to create new real estate for the rapidly growing city. The area now known as the Embarcadero and Financial District sit on land that was once the harbor's edge. Up to forty ships still lay buried under the city's foundations. In the late 1970's, the ship formerly known as the Niantic was excavated from the corner of Clay and Sansome Street near the Transamerica Pyramid. The former whaling ship was abandoned and found new life as a saloon, hotel, and storage before it was destroyed in an 1851 fire. Many artifacts were still entombed in the burnt-out tomb and can be seen on display in a local museum.

The hordes of prospectors heading to the gold fields all needed one thing, reliable pants. Conditions on the claims meant that durable clothing was a must have as much as the gold pan and shovel. In 1853, Levi Strauss opened a dry goods store in San Francisco to supply the hopeful miners. A Nevada tailor and immigrant named Jacob Davis often bought bolts of durable denim and canvas from Strauss's shop. Based on experience serving prospecting needs, Davis began to reinforce stress zones of the pants with copper rivets to reduce the need to repair or patch. In 1872 the two men joined forces to patent the design and manufacture the first "waist overalls" later commonly

known as "jeans" for sale. Levi Straus & Co. consider May 20, 1873, the date the patent was entered, as the "birthday" of their history making pants. However, the world would have to wait until 1901 for the addition of a back pocket to the pattern. The durability of the rivet reinforced pants led to widespread popularity. Eventually, they would become emblematic of the American West experience and still remain a popular practical and fashion choice all over the world. *Cont. next page*

Every textbook that details the origins of the Gold Rush features the story of the discovery at Sutter's Mill. But did you know that the Gold Rush's promises of riches absolutely ruined the fortune of the man who owned the land where the first gold nuggets were found? John Sutter emigrated to California with the dream of setting up an agricultural settlement. He was one of the rare non-Mexican or Spanish born persons to be granted land grants in 1839 from the Mexican government



United States. Despites pleas and petitions, the U.S. declined to acknowledge Sutter's ownership of

and quickly built what would become known as Sutter's Fort in the area called New Helvetia with plans to develop expansive cattle ranching and farming operations. The location was perfectly situated on the Oregon Trail and near inland waterways leading to San Francisco.

That nugget spelled disaster for Sutter's dreams. Not only did all of his employees abandon their work, but they often stole resources and supplies to set up their own mining ventures. The influx of prospectors dealt another blow as the land was torn up in the search for new gold deposits. The final blow came when the Mexican government transitioned control of the California territory to the

the land forcing him into bankruptcy in 1852. Squatters took over both the remains of the Fort and the surrounding area. The land that would soon become the state capital of Sacramento, CA. The structures that formed the core of Sutter's Fort still exists and has been preserved as a State Historic Park smack in the middle of Midtown Sacramento. The simple building stood testament to a migration of nearly 300,000 people and the complete upheaval of local indigenous cultures.

After time the California government awarded Sutter a small pension as reimbursement for taxes and he ended his days on the East Coast still seeking to get Federal reimbursement for the loss of land

rights over the roughly 48,800 acres original granted by the Mexican governor. He died before the \$50,000 payment could be voted on by Congress. Ironically, that same region is one of the richest agricultural and cattle ranching zones in Californian today.
